SATORI GOVERNING BOARD**

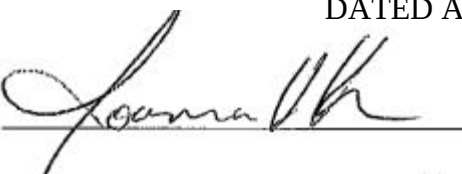
