**Call to the Public**-- Pursuant to A.R.S. 38-431.01.G, the Governing Board may allow individuals from the public to address the Governing Board. Comments shall be limited to issues within the jurisdiction of the Governing Board. The Governing Board shall not discuss or take legal action on matters raised during an open call to the public unless the matters appear on this agenda for discussion and legal action.
